Crypto-to-crypto trades are settled within minutes of receipt of cleared assets using Fireblocks or any client-specified and white-listed wallet. Fiat settlement can be made typically on the same day (T+0) subject to bank cut-off times without size restrictions, subject to due diligence and KYC criteria.

All trades are settled on a DVP basis.
